## Terms and Conditions

### 1. Registration

- 1.1. Acceptance of the registration is subject to availability of seats for the programme run. For certain programmes (e.g., CS1010X), acceptance of registration is subject to the participant fulfilling the programme's minimum pre-requisites.
- 1.2. An email confirming the programme will be issued usually two (2) weeks before the programme start date.
- 1.3. The personal data collected will be used for the purposes of managing and administering the programme, examination and certification and may be disclosed to NUS SCALE's partners and service providers, certification awarding bodies, examination agencies and funding agencies. The registered participant's consent of the above is required for the attendance of the programme.

### 2. Payment

- 2.1. The registered participant is deemed to have accepted the terms and conditions herein upon payment of the programme fees.
- 2.2. All payments have to be received by NUS SCALE by the payment due date. Where applicable, the seat confirmation is only issued when the payment is received by NUS SCALE before the programme commencement.
- 2.3. All payments are to be made in Singapore dollars. Payment can be made via:

  - Cheque

### 3. Programmes with SkillsFuture Singapore ("SSG") Training Grants for Singapore Citizen/Permanent Resident Participants

- 3.1. The sponsoring organisation shall register with SSG at [www.skillsconnect.gov.sg](http://www.skillsconnect.gov.sg) for the programme fee grant and absentee payroll claims before the commencement of the programme.

- 
- 3.2. A Singapore Citizen/permanent resident participant shall not be eligible for the programme fee grant or absentee payroll claim if he/she:
- (a) is repeating a programme; or
  - (b) has already attended a similar non-WSQ programme; or
  - (c) has already obtained Statement of Attainment for the same competency units in another WSQ programme.
- 3.3. In the event that SSG withdraws the approval for NUS SCALE to conduct the programme, the sponsoring organisation or eligible participant, shall upon demand by SSG and/or NUS SCALE, be jointly and severally liable to refund and payback to SSG and/or NUS SCALE, all programme fee grants and absentee payroll claim which have been disbursed.
- 3.4. The Singapore Citizen/permanent resident participant who has received the training grant shall be liable to payback the SSG grant plus the prevailing Goods & Services Tax ("GST") to NUS SCALE under any of the following circumstances:
- Failure to fulfil a minimum attendance of 75% for the programme
  - Premature withdrawal from the programme
  - Failure to complete all prescribed coursework, examinations and/or assessments for the programme

#### **4. Programmes with e2i Subsidy for Singapore Citizen/Permanent Resident Participants**

- 4.1. The Singapore Citizen/permanent resident participant who has received the e2i subsidy shall be liable to payback the e2i subsidy plus the prevailing Goods & Services Tax ("GST") to NUS SCALE under any of the following circumstances:
- Failure to fulfil a minimum attendance of 75% for the programme
  - Premature withdrawal from the programme
- 4.2. NTUC members enjoy 50% of the unfunded programme fee support for up to \$250 each year for programmes supported under UTAP (Union Training Assistance Programme). Terms and conditions apply.

#### **5. Changes and Modifications**

- 5.1. The programme schedule, content, fees and availability are subject to change.
- 5.2. In the event of any changes as stated in Clause 4.1, the registered participant may exercise one of the following options:
- (a) Enrol in the same programme with the new schedule. If there is a change in the programme fee for the said programme, the registered participant shall pay the difference between the old fee and the new fee.
  - (b) Enrol in another programme offered by NUS SCALE. If the fee of the replacement programme is higher than what was paid, the registered

participant shall pay the difference between the fees. If the fee of the replacement programme is less than what was paid, NUS SCALE will refund the difference to the registered participant.

- (c) Withdraw from the programme. NUS SCALE will refund the fee if the registered participant had already paid the fee.

## 6. Substitution

- 6.1. The registered participant may invite another person, or another person within the same organisation, to substitute his/her place in the programme. All requests to transfer a registration must be received in writing at [scale.execed@nus.edu.sg](mailto:scale.execed@nus.edu.sg) no later than five (5) working days prior to the start of the programme. Such requests are subject to approval by NUS SCALE, especially for programmes (e.g., CS1010X) that require participants to meet minimum pre-requisites.

## 7. Cancellation, Withdrawal and Refund

- 7.1. NUS SCALE reserves the right to cancel any programme at its absolute discretion without assigning any reasons for the cancellation. In the event that the registered participant's programme is cancelled prior to its commencement, NUS SCALE will refund the full programme, examination and other applicable fees already paid by the registered participant.
- 7.2. Any request to withdraw from a confirmed programme must be received in writing. The refund policy for a withdrawal is as follows:
- Fifteen (15) working days or more before programme commencement - 100% refund of all programme and/or examination fees paid (if any) excluding application fee.
  - Between seven (7) to fourteen (14) working days before programme commencement - 75% refund of all programme and/or examination fees paid (if any) excluding application fee.
  - Between one (1) to six (6) working days before programme commencement - No refund of all programme and/or examination fees and application fee paid (if any).
  - "No-show" on first day of programme or after programme commencement - No refund of all programme and/or examination fees and application fee paid (if any).
  - When access is granted for online programmes - No refund of all programme and/or examination fees and application fee paid (if any).

## 8. Reschedule or Cancel Examination Registration

- 8.1. Notice of any rescheduling or cancellation of an examination registration (for examinations conducted by NUS SCALE) must be received at least seven (7) working days prior to the examination date. The registered participant can defer taking the examination to a later date within the duration of the programme.<sup>1</sup>

- 8.2. Any reschedule or cancellation of an examination registration is subject to an administration fee, as follows, which will be charged by NUS SCALE:
- Reschedule registered examination date - \$50
  - Cancel examination registration - \$100
- 8.3. Cancelling or rescheduling an examination registration less than seven (7) working days without a written notification is subject to a forfeit of the examination fee. The examination fee is also forfeited for a no-show on the examination day.
- 8.4. If valid reasons are provided, no administration fee will be imposed. The sponsoring organisation must provide a written request to NUS SCALE with supporting documents at least seven (7) working days before the examination date. Valid reasons include:
- Death or illness of immediate family members
  - Military deployment (in-camp training)
  - Hospitalisation
  - Official overseas business trips
- 8.5. A cancellation request received with less than seven (7) working days' notice and "no-show" will not be granted a deferment to a later date.
- 8.6. For medical emergencies, submission of the appropriate medical advice must be made within seven (7) days after the "no-show" on the examination date.<sup>2</sup>

## 9. Loss and Damage

- 9.1. NUS SCALE does not accept responsibility and expressly excludes liability for any loss or damage to the registered participant's property that occurs whilst the participant is on the programme. The participant is fully responsible for his or her personal belongings and shall take particular care not to leave personal belongings unattended.

## 10. Certificates

- 10.1. The NUS SCALE Certificate of Completion, or an equivalent documentation, will be issued to participants who have successfully fulfilled the programme requirements.
- 10.2. A request for reprint of certificates can only be submitted once. Charges apply and are as follows:

## 12. Disclaimer

- 12.1. NUS SCALE or its employees shall not be liable to any registered participant or third party for any personal injuries or any damages whatsoever (including, without limitation, direct, indirect, incidental, consequential, special, exemplary or lost profits) resulting from the registered participant's application for or participation in any programme conducted by NUS SCALE.
- 12.2. The registered participant agrees to defend, indemnify, and hold harmless NUS SCALE, its subsidiaries, officers, directors, employees, agents, affiliates and partners from and against any claim, demand or legal proceeding, including legal expenses, made by any third party or arising from or out of the registered participant's breach of the terms and conditions herein.

## 13. Governing Law and Jurisdiction

- 13.1. These terms and conditions are governed by the laws of the Republic of Singapore. Any and all disputes, controversies, or differences which may arise between NUS SCALE and the sponsoring organisation/registered participant, out of or in relation to or in connection with this programme, or for the breach thereof, shall be finally settled in arbitration by one arbitrator and be conducted in English language in accordance with the Arbitration Rules of Singapore International Arbitration Centre for the time being in force which rules are deemed incorporated by reference into this clause.
